

The students will be given long term loans for education out of the income of this Endowment Fund. The Board of Trustees of the WMOCF held in South Africa on 17th November 2013, has authorized the WMO Pakistan Chapter to utilize the Trustees' Fund lying in its Bank Accounts in Pakistan.

It was also stressed that an all out efforts be made to increase the number of members of WMO so that the World Memon Organisation truly becomes an international body of the Memon Community.

Let all of us join hands to strengthen the WMO to bring about a revolution in the Memon community and pave the way forward. Let there be not a single member of the Community uneducated and live below the poverty line. This can only be achieved if all of us sincerely strive for it.

# 12<sup>th</sup> AGM Report South Africa



The 12th AGAM of the WMO and the 12th AGM of WMO CF was hosted by the Africa Chapter in the resplendent city of Johannesburg, South Africa on 7th and 8th November 2014, at the Sandton Convention Center.

It was a celebration of Memon brotherhood and a watershed event in the history of WMO. The grandeur and scale of the proceedings were previously unmatched. The warm camaraderie, fellowship and affiliation of all Memon's around the globe towards this wonderful organization were strikingly evident by the colossal turn out at the event.

Delegates numbering over 200 representing India, Pakistan, Sri Lanka, Middle East, America, England and of course the home continent of Africa participated in the AGM.

The AGAM endorsed WMO as the truly global, umbrella organization which unites all Memon's under its wings.

The most noteworthy development of the 12th AGM was the Merger of WMO and WMO CF into one Organization. It was the outcome of eighteen months of hard work, discussion, deliberation and conclusion arrived at by the Governance Committee. The Committee was appointed in February 2013 at Colombo under the

capable leadership of Mr. Yunus Suleman.

6th November marked the arrival of most of the delegates from around the globe and signaled the start of a momentous AGAM which was the culmination of three months of rigorous planning and hard work by the African contingent.

The majestic Turkish Masjid was a sight to behold as the delegates were taken to perform Maghreb Salah at this most magnificent monument. Next was a tour of priceless artifacts on the Masjid premises and dinner at the adjoining restaurant. The food was delectable and the ambience was made ever more romantic with the candle light dinner. Truly fine dining experience.



## Day 1 – 7th Nov 2014

The Governance Committee met in the morning to put the final touches to months of consultations, deliberations and arrived at a consensus to present the final proposal for the Merger of the 2 institutions and formulation of the new constitution.

The Governance Committee meeting was followed by the WMO CF Board of Trustee Meeting presided over by Chairman WMO CF Mr. Suleiman Noor Mohamed (Solly Noor).

Zakath Collections, Zakath Disbursement, Trustee Fee Shortfalls, Investment update, the Merger and adoption of the new constitution were predominant discussions of the meeting. A very encouraging sign was the improvement of the overall management of WMO properties in Dubai and the marked increase in revenue from these investments. Jummah Salah was conducted by Maulana Nabeel at the same venue and a scrumptious buffet lunch was laid out for the delegates.

This was followed with The Board of Management Meeting of the WMO chaired by WMO President Mr. Abdul Satar Dada. This part of the BOM meeting was devoted to the Presentation of Regional Chapter Reports by the respective Vice Presidents.

The dinner was at the Killarney Country Club. The selection of venues and the mouth watering cuisine epitomized the unmistakable effort and planning made by our magnanimous hosts towards making this trip so memorable.

The articulate Mr. Feizul Ayob took the mike and started off proceedings. There was an eloquent rendering of a Qirat from the Holy Quran. The food was top-notch and was only surpassed by the desserts. The entertainment quota of the evening was raised substantially by the newest trustee Mr. Haroon Sacranie of Malawi who had the crowd in splits thanks to his innumerable, witty jokes in Memoni language.

The morning session began with the continuation of the Board of Management meeting. The predominant agenda items were Audited Accounts, Zakath Disbursement, Election Report and

## Merger of WMO and WMOCF




elect the Office Bearers of the Management Committee.

# The Month of Safar during the Days of Ignorance



The Muhaddithin have recorded many of the superstitions harboured by the Arabs during the Days of Ignorance. A few are mentioned below:

1. The pre-Islamic Arabs believed Safar to be a snake which lives in the stomach of a human being and when hungry, bites the person. This is the discomfort one experiences when gripped by the pangs of hunger.
  2. Some said Safar are worms which originate in the liver and ribs due to which the colour of the person becomes yellow, a condition we know today as jaundice.
  3. According to some, the month of Safar flanked by Muharram and Rabi al Awwal is full of calamities and misfortune.
- With the advent of Islam and the teachings of Sayyadina Rasoolullah (SallAllaho Alaihi wa Sallam), all evil and incorrect beliefs common in pre-Islamic times were discarded.

## Incorrect Beliefs:

Today too, there are some Muslims who hold incorrect beliefs regarding the month of Safar.

1. A nikah performed in this month would not be successful.
2. This month is full of misfortune and calamities.
3. To commence any important venture, business etc. during this month will bring bad luck.
4. The first to the thirteenth of Safar is ill-fortune and evil.
5. The person who distributes food or money on the 13th of Safar will be saved from its ill-fortune.
6. To celebrate the last Wednesday of Safar and regard it as a holiday.

## What to do:

1. To shun all types of erroneous beliefs regarding the blessed month of Safar.
2. To understand that the most unfortunate person is he who disobeys Allah Ta'ala's commandments e.g. does not perform the five daily salaah etc. It is narrated in a hadith that Rasoolullah (SallAllaho Alaihi wa Sallam) said: "Pray, O Allah! Cause not anyone of us to be a wretched destitute." He then asked: "Do you know who is a wretched destitute?" Upon the request of the Sahabah (Radi Allahu Ta'ala Anhum) he replied, "A wretched destitute is he who neglects his salaah."
3. We should understand that all conditions which befalls us, good or bad, favourable, or unfavourable are from Allah Ta'ala, (as a result of our actions). Allah Ta'ala says: "Whatever misfortune befalls you, it is due to the things your hands have wrought, and He forgives many a sin." (Surah 42 - Verse 30).

## This can also be confirmed by the following Hadith:

Sayyadina Jabir (Radi Allahu Ta'ala Anhu) has said that, "I have heard Sayyadina Rasoolullah (SallAllaho Alaihi wa Sallam) saying, the descending of illness and evil superstition befalling in the month of Safar is untrue."

વાર્ષિક સામાન્ય સભાના

ગવર્નિંગ કમિટીની મિટિંગ પછી WMOCFના બોર્ડ ઓફ ટ્રસ્ટીની બેઠક જનાબ સુલેમાન નૂરમોહમદ (સોલી નૂર)ના ચેરમેનપદે મળે હતી. ઝકાતની વસૂલી અને વ્હેંચણી, ટ્રસ્ટીઓની ફીની વસૂલીમાં ઘટાડા, ઈન્વેસ્ટમેન્ટની છેલ્લી પરિસ્થિતિ, બંને સંસ્થાઓના જોડાણ અને તેના નવા બંધારણના મુદ્દાઓ પર વિચારણા કરવામાં આવી હતી. દુબઈ ખાતેની WMOની મિલ્કતોની વ્યવસ્થામાં સુધારા અને એ ઈન્વેસ્ટમેન્ટના નફામાં આવેલા નોંધપાત્ર વધારા પ્રત્યે સંતોષ વ્યક્ત કરાયો હતો.

જુમ્હાની નમાઝ અને લંચ પછી WMOના પ્રમુખ અ. સત્તાર દાદાના ચેરમેનપદે WMOના બોર્ડ

બોર્ડ આ બાબત જવલંત આગેવાની બદલ સત્તાર ભા અને સોલી માનો આભાર માનતા ખાસ

ઠરાવને મંજૂરી આપી હતી. બેઠકમાં છેલ્લા ચાર વરસોથી WMOનું કુશળતાપૂર્વક સંચાલન કરવા બદલ વિદાય લઈ રહેલા પ્રમુખ જનાબ. અ. સત્તાર દાદાને ઉભા થઈને તાળીઓના ગડગડાટ સાથે અભિવાદન કર્યું હતું.
